

# Greatfields Pupil Premium Overview and Spending 2020/21

## **Background:**

The Pupil Premium was introduced in April 2011. It is funding that is given to schools by the Government to raise the attainment of disadvantaged pupils. In 2012-2013 the Pupil Premium was extended to pupils who have been eligible for free school meals at any point in the last six years (Ever6 Free School Meals measure). Schools also receive funding for children who have been looked after continuously for more than six months, and a smaller amount for the children of service personnel.

The following document details how Greatfields School makes use of the additional Funding it gains through Pupil Premium, along with details of the impact it has on the pupils.

## **Opportunity to claim FSM:**

You can register your child for Free School Meals if you get any of these benefits:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The Guarantee element of State Pension Credit
- $\bullet$  Child Tax Credit, provided they are not entitled to Working Tax Credit and have an annual income (as assessed by HM Revenue & Customs) that does not exceed £16,190

#### **Context**

Greatfields School is situated on the Gascoigne estate in Barking in the 12th most deprived local authority in the country. Gascoigne is the most deprived ward in the local authority. At Greatfields, our mission is to provide a first class education to allow all students to fulfill their dreams. As part of the additional provision made for pupils belonging to vulnerable groups, we routinely address the needs of pupils who may be socially disadvantaged, whether they receive free school meals or not. There are many reasons for this, not least the fact that many of our parents have no recourse to public funds for a variety of reasons, including immigration status. As





such, Greatfields School recognises that not all pupils who are socially disadvantaged qualify for free school meals and therefore reserves the right to allocate Pupil Premium funding to support any pupil or indeed groups of pupils who are legitimately identified as at a social disadvantage. In the current climate of Covid 19 and the six month lockdown, the alloction of these funds to any of our vulnerable students is even more important.

We have 299 Pupil Premium students on roll (41.41% compared to national, 28%). The number of students eligible to receive Pupil Premium funding has gradually increased over the past few years. In the current Year 11 cohort 36.89% are eligible; this increases to 45.71% in the current Year 7 cohort. The school received £201,025 of additional funding in 2019-29 and we estimate to receive £285,545 in 2020-21.

#### **Barriers:**

Our Pupil Premium students face a number of barriers which have a significant impact on their learning and many of these barriers have been exacerbated by Covid 19:

- 1) Lack of access to internet or a computer at home;
- 2) no quiet space at home to work;
- 3) not having breakfast in the mornings at home;
- 4) lack of clear boundaries and routines at home;
- 5) not enough money to buy new uniform when they outgrow or damage their uniform:
- 6) negative influences outside of school;
- 7) no access to sports clubs and other activities outside of school;
- 8) no family background of going to university and/or low aspirations in family network.





#### **Priorities:**

Unfortuntely due to Covid restrictions we are currently unable to run our extended curriculum or breakfast club, both of which are key barriers to our students. As such, Pupil Premium allocation this year is being targeted on the other barriers that our students face. As and when restrictions are lifted, we will divert some of the funds back to our extended currriculm and breakfast club programmes.

The three key spending priorities for this year are currently:

- Reducing the rates of exclusion for Pupil Premium students
- Reducing the progress gap for Pupil Premium students.
- Improving students' access to remote learning

These priorities have been identified via student questionnaires, focused student interviews, staff questionnaires and staff consultation, interrogation of attainment, behaviour and attendance data.

Reducing the progress gap for Pupil Premium students			
We have created additional classes in Years 7, 8 and 9. This represents an additional 75 periods per week which is the equivalent to three additional teachers.	£125,532	The students in these classes have lower prior attainment than the other groups and are significantly below national standards.
